Unsolicited offers are liable to be ignored/outright rejected.** However, suppliers who desire to participate in such tenders in future may apply for registration with the Procuring Entity as per procedure.

3. The Bid is to be submitted as per SOW, SLA, STC and all Enclosures attached with this tender.
