This notice is being published for information only and is not open invitation to quote in this limited tender enquiry. **Participation in this limited tender enquiry is by invitation through e-mail only and is limited to the nominated firms. Unsolicited offers are liable to be ignored/outright rejected.** However, suppliers who desire to participate in such tenders in future may apply for registration with the Procuring Entity as per procedure.

3. The Bid is to be submitted as per SOW, SLA, STC and all Enclosures attached with this tender.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
