If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. - 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Any information / drawing etc. shall not be copied, transcri bed, traced or reproduced in any other form or otherwise in whole / part or dup licated, modified, divulged and / or disclosed, to a third party not misused, use d in any other form whatsoever without purchaser's prior consent in writing ex cept to the extent required for the execution of this order. At the time of tende ring the purchaser has to give an undertaking in favour of GRSE that in the eve nt of any breach of the above provisions, he would make good of any loss / cos t / damage / any other claim whatsoever preferred by anybody to GRSE in this respect.

#### B3. **PATENT RIGHT:-**

GRSE shall be completely absolved of any responsibility towards any infringem ent of Patent Right etc. i.e. a clear and quite possession of goods should take p lace with the passing of title on execution of the order.

#### B4. ARBITRATION:-

- (i) If at any time, before during or after the contract period, any unsettled clai m, question, dispute or difference arises between the parties, upon or in rel ation to or in connection with or in any way touching or concerning this ord er, the same shall be settled/adjudicated through Arbitration to be conduct ed by a Sole Arbitrator, to be appointed by the parties on mutual consent, in accordance with the provisions of the Arbitration and Conciliation Act, 19 96.

- (iv) The Award of the Sole Arbitrator shall be final, conclusive and binding upo n the parties.

- (vii) The cost of the arbitration, fees of the arbitrator, remuneration of the sten ographer and clerk, stamp paper etc. shall be shared equally by the partie s, unless otherwise directed by the Sole Arbitrator. - (viii) The language of the proceeding shall be in English.
