Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. #### B2. **SECRECY CLAUSE:**

All information given to the supplier for the execution of the order is to be treated as SECRET/CONF IDENTIAL. The technical information, drawings, specification and other related documents forming part of this Enquiry / order are the property of Purchaser and shall not be used for any other purpo se except for the execution of Order. Any information / drawing etc. shall not be copied, transcribe d, traced or reproduced in any other form or otherwise in whole / part or duplicated, modified, divu lged and / or disclosed, to a third party not misused, used in any other form whatsoever without p urchaser's prior consent in writing except to the extent required for the execution of this order. At the time of tendering the tenderer has to give an undertaking in favour of G.R.S.E. that in the even t of any breach of the above provisions, he would make good of any loss / cost / damage / any oth er claim whatsoever preferred by anybody to G.R.S.E. in this respect.

#### B3. **PATENT RIGHT:**

GRSE shall be completely absolved of any responsibility towards any infringement of Patent Right etc. i.e. a clear and quite possession of goods should take place with the passing of title on executi on of the order.

#### B4. **EXECUTION OF ORDER:**

Order once placed must be executed in full within the stipulated delivery period, unless otherwise speciall y agreed by the buyer in writing.

#### B5. **CANCELLATION OF ORDER:**

GRSE reserves the right to cancel the **tender / order in part / ful**l at any point of time without as signing any reason thereof and with no financial implication.

#### B6. **FORCE MAJEURE CLAUSE:**

Standard Force Majeure Condition at the supplier's own works / establishment shall only be accept

ed. The failure of the sub-contractors of the suppliers shall not be accepted as a Force Majeure Con dition. Vendor is to submit relevant proof / document well in time to buyer to inform F.M. condition

## β7. **ARBITRATION:**

- i) If at any time, before during or after the contract period, any unsettled claim, question, dispute or differ ence arises between the parties, upon or in relation to or in connection with or in any way touching or con cerning this order, the same shall be settled/adjudicated through Arbitration to be conducted by a Sole Ar bitrator, to be appointed by the parties on mutual consent, in accordance with the provisions of the Arbitra tion and Conciliation Act, 1996.
  - ii) In the event the parties fail to mutually appoint a Sole Arbitrator within 30 days from the receipt of a request by one party from the other, then either of the parties may approach the Hon'ble High Court at Calcutta under the provisions of the Arbitration and Conciliation Act, 1996 for appointmen t of a Sole Arbitrator by the Hon'ble Court.
  - iii) Such arbitration shall, in all respects, be conducted in accordance with the provisions of the Arb itration and Conciliation Act, 1996 and the rules framed there under or any statutory modification or re-enactment thereof for the time being in force.
  - iv) The Award of the Sole Arbitrator shall be final, conclusive and binding upon the parties.
  - v) In the event of the death or resignation or incapacity or whatsoever of the said Sole Arbitrator if appointed by the parties mutually the said parties may again appoint a suitable Substitute Arbitrat or in place of the erstwhile Sole Arbitrator to continue with the proceedings. In the event of appoint ment of the Sole Arbitrator by the Hon'ble High Court at Calcutta on death or resignation or incapa city or whatsoever of the said Sole Arbitrator, either of the parties in this behalf, may make an application to the Hon'ble High Court at Calcutta for appointment of a Substitute Arbitrator and the Hon'ble Court may pass such orders as it deems fit and proper.
  - vi) Also in the event an Arbitration award is set aside by a competent court the parties my appoint a Sole Arbitrator mutually or on failing to appoint a Sole Arbitrator mutually within the statutory pe riod then either of the parties may file an application before the Hon'ble High Court at Calcutta un der the provisions of the Arbitration and Conciliation Act, 1996 for appointment of a Sole Arbitrator by the Hon'ble Court in accordance with the provisions of the Arbitration & Conciliation Act.
  - vii) The cost of the arbitration, fees of the arbitrator, remuneration of the stenographer and clerk, s tamp paper etc. shall be shared equally by the parties, unless otherwise directed by the Sole Arbitrator. The venue of arbitration shall be at Kolkata and unless otherwise decided by the parties or by the Sole Arbitrator himself, the venue shall be the premises of Garden Reach Shipbuilders & Engin eers Ltd. located at 43/46, Garden Reach Road, Kolkata 700 024.
  - viii) The language of the proceeding shall be in English.

#### B8. **JURISDICTION:**

All disputes arising out of the contract if required to be referred to a court of law, the jurisdiction of the case would be under Kolkata Court irrespective of the location of the vendor.

#### B9. **COMPLIANCE WITH LAWS:**

Vendor is warranted that all goods purchased against the enquiry shall conform to all applicable c ities, States and Central Laws, Ordinances and Regulations. Further, Vendor shall indemnify / defe nd / relieve GRSE harmless from loss, cost of damage, by reason or any actual or alleged violation thereof.
