6. General Eligibility Criteria: -

Subject to provisions in the Tender Document, all bidders has to fulfil the 'Eligib ility' and 'Qualification criteria. Participation in such a Pre-bid Conference is not mandatory. If a bidder does not participate or submit any que ry, then no subsequent representations from them regarding the Technical/ co

mmercial specifications/ conditions shall be entertained.

9. Submission of Bids:

Bids must be uploaded till the deadline for submission mentioned in TIS. If the office happens to be closed on the deadline to submit the bids as specified a bove, this deadline shall not be extended.

Unless otherwise specified, in TIS, originals (or self-attested copies of originals – as specified therein) of specified scanned uploaded documents must be physically submitted sealed in double cover and acknowledgement be obtained before the bid submission deadline at mentioned venue. Failure to do so is likely to result in the bid being rejected. If the office is closed on the deadline for physical submission of originals, it shall stand extended to the next working day at the same time and venue.

No manual Bids shall be made available or accepted for submission (except for originals of scanned copies as per sub-clause above).
