- 1. Garden Reach Shipbuilders & Engineers Ltd. (GRSE) is a premier warship-building company with offshore fabrication yards in India, operating under the administrative control of the Ministry of Defence, Government of India. Renowned for its excellence in the defence sector's shipbuilding industry, GRSE has established itself as a key contributor to India's naval strength and maritime capabilities. Its Shipbuilding Division specializes in constructing a wide array of state-of-the-art naval vessels, reflecting the company's engineering prowess and technological advancement. GRSE's outstanding performance has been recognized nationally, earning the prestigious title of "Best Performing Shipyard" for four consecutive years (2011–2014), conferred by the Hon'ble Raksha Mantri.
- 2. GRSE since 1960 has constructed warships for various roles, starting from state-of-the-art Frigates & Corvettes, Offshore Patrol Vessels, various types of Survey Vessels, Fast Patrol Boats etc. **So far GRSE has delivered more than 100 Ships to its customers.**
- 3. GRSE (hereinafter referred to as Builder) has been awarded with a contract for construction of 1 (One) number of Operation Research Vessel (ORV) from National Centre for Polar & Ocean Research (NCPOR) under Ministry of Earth Sciences, Government of India (hereinafter referred to as Buyer) towards Design, Construction, Equipment, Floating, Launching /Sea Trial Run and Delivery Ex-Shipyard Kolkata.
- 4. **GRSE** intends to cover the risk for 1 (one) ORV Yard No 3041 by Builders Risk Insurance under Institute Builders Risk Clause, (01.06.1988). The details of various parameter of insurance are provided in Annexure-B (Techno-commercial Bid).
- 5. The vessels particulars, Type of Vessels, Yard Number, Period of Construction, Expected Keel Laying Month, Expected Month of delivery and corresponding Sum Insured, Location is described in point 9 below read with **Annexure-I**

- 6. The vessel shall be built at Builders Yards at Main Unit/ Rajabagan Dockyard (RBD) unit/ Fitting Out Jetty (FOJ) Unit/ KPDD Unit. All are situated at Kolkata, West Bengal and addresses are given in Annexure I.
- 7. The period of insurance cover is required from the Date of Keel laying till the delivery and acceptance date of the vessel.

8. Bidders Eligibility Criteria

- (a) The bidder must have previous experience in underwriting of Builders Risk Insurance for shipbuilding works as a lead insurer/co-insurer and the bidder has issued policy for Builders Risk Insurance or named as a co-insurer in a policy. - (b) The bidder has to attach the policy copy of the BRI Policy in support of above criteria.

 - (a) Yard 3041: Expected keel laying month December 2025

(b) Expected Date of delivery January, 2028. (26 months tentative) However, these dates may vary.

12. Terms and Condition of the Tender:

- (a) The Policy is required to be issued in the name of GRSE covering the respective rights and interest of Contractor/ Sub-contractors.
- (b) There will be a waiver of subrogation against any other insured, principal, contractors, subcontractors, consultants etc.
- (c) The period of insurance coverage is required from the date of keel laying till the delivery and acceptance of the vessel & the premium shall be calculated on the total sum insured for the full policy period. Stamp duty to be calculated on BRI Full Sum Insured and to be charged with the first instalment. GST to be charged appropriately. Total premium to be divided and payable in equated quarterly instalment over the vessel policy period. The last instalment shall be paid six months before the end of the policy tenure.

13. Details of Policy Coverage:

The Builders Risk Insurance coverage will include All Risks of physical loss or damage to the project property situated at the insured premises, yard, including inventories in the stores, the ship under construction, all machinery, materials, equipment, appurtenances, and outfits built into or installed on or kept alongside the ship under construction, as well as any modifications. The coverage will be provided in accordance with the Institute Builders Risk Clauses dated 01-06-1988 and will extend to include risks associated with fabrication and other works at subcontractors' premises anywhere in India. Additionally, the policy will cover the storage & transit of inventories, including those lying alongside the ship under construction and within the yard premises.

This coverage will be subject to specific add-on covers and waivers as below:

- a) <u>Inclusion of Earthquake and Volcanic Eruption</u>. (By deletion of Exclusion Clauses No.6 of Institute Clauses for Builders Risks (1st. June, 1988).
- b) <u>Inclusion of War Risk</u> (i.e. by deletion of Exclusion Clause No. 21 of the Institute Clauses for Builders Risks (1st. June, 1988).
- c) <u>Inclusion of Strike, Malicious Act, Riot, Civil Commotion</u> (i.e. by deletion of Exclusion. Clause No.22 & 23 of Institute Clauses for Builders Risks (1st. June, 1988) inclusive of terrorism.
- d) Coverage shall be extended to include all temporary works, plant, equipment, machinery, materials, outfits, and any related property associated therewith, regardless of whether such items are intended to form a permanent part of the construction works or not. This extension will encompass all site preparatory activities, as well as any subsequent risks associated with these items, until the final delivery to the Buyer.
- e) Storage Coverage to extend to all items, including hulls, machinery, and materials, while stored at the Builders Yard, internal/external storage areas, Sub-Contractors' Premises and associated premises including temporary storage whilst at Builder's Yard and at Builder's premises (owned/ occupied) elsewhere within the port or defined place of construction at which Builder's Yard is situated and whilst in transit between such locations, provided such item has already been allocated to the Vessel.

- f) Transit Coverage must encompass all movements of items to and from anywhere between Builder's Yards, different storage areas, work locations as mentioned above.
- g) Coverage required for physical loss and/ or damage to the property insured occurring during policy period and resulting from a defective part, faulty design, faulty materials, faulty or defective workmanship or latent defect even though the fault in design may have occurred prior to the attachment date of the policy.
- h) Policy to cover failure of launching and all subsequent expenses incurred in completing the launch.
- i) The policy will cover the movement of the vessel, whether under its own power or in tow inter unit (Main-RBD-FOJ-KPDD) or vice versa and/or to and from any wet or dry dock, harbour, ways, cradles, or pontoons within the places of construction. This includes movements, either loaded or in ballast, for fitting out, docking, trials, or delivery within a distance of 250 nautical miles from the port or place of construction, as often as required.
- j) There could be several trials before Final Trial and the proposed BRI Cover shall continue seamlessly until delivery and acceptance to the Buyers.
- k) Policy will also cover, re-trial expenses including all additional expenses incidental to re-trial in the event of trials being unsuccessful on account of sudden and accidental events and /or Act of God perils.
- 14. LAUNCHING & SEA TRIAL: The policy must cover both Launching and Sea Trials. The type of launching has not yet been finalized and may vary depending on the situation, as determined by GRSE. The vessel will be launched and undergo trials in a phased manner across different months/ years. BRI coverage must include HAT (Harbour Acceptance Trials)/Basin Trial, CST (Contractor Sea Trials),FMT (Final Machinery Trials), Sea/River Trials, and all associated sorties, including delivery, within a limit of 250 Nautical Miles.

15. **DEDUCTIBLE:**

Deductible should not exceed Re.0.15% of Sum Insured (Rs.1.24 Cr) of the vessel sum insured during construction and Re.0.30% of Sum Insured (Rs.2.47 Cr.) of vessel sum insured during launching / Trial Run period for all claims including Collision Liability, Sue & labour Charges, removal of wreck etc.

16. SPECIAL CONDITION -BRI POLICY(S) PREMIUM RATES FOR EXTENSION(S):

Extension of Policy: This policy period of the vessel is extendable in case of delay in completion of the vessel. During extension, same rate of premium to be calculated on monthly prorate basis i.e. total premium paid under respective policy is divided by the number of months covered as the case may be with same terms and conditions of the policy to continue provided the incurred claim ratio is not more than 70% of the policy premium received inclusive of premium for extension(s) under the respective policy.

This is a mandatory condition of the Tender and non-acceptance of this condition by the bidder will render the quotation invalid and to be rejected.

- 17. **LOSS HISTORY**: GRSE has so far delivered more than 100 (hundred) ships to various customers in India and abroad. There is no past loss history on account of various BRI policy of GRSE.
- 18. YARD SURVEY: Yard survey was conducted by competent Marine Surveyor M/s. Aqualis Braemar Marine Service LLC, Dubai, UAE on 11th & 12th. November, 2024 for Main Unit, RBD Unit and FOJ Unit. All the compliance has also fully been made by GRSE and final Addendum Report with full compliance of the above survey agency dated 02-06-2025 was issued certifying all compliance. The Overall Grading of the Shipyard is Final "C. Bidder may also access, if so desire, GRSE's Risk Inspection Reports of the year January, 2024 prepared by our Insurance Intermediary- M/s. Sun Risk Management and Insurance Broking Services Pvt Ltd. Bidders are free to inspect/survey GRSE facilities prior submission of their bid at their own cost. Cost of any survey, if insisted by the insurer, after issuance of insurance policy is also to be borne by the insurer.

19. INSTRUCTIONS TO THE BIDDER

Quotations under two segments (Under two-part bid system)

Accordingly, Competitive quote is invited from the bidder on Gross basis including all loading & discounts in two part bid system.

It is to be noted that price bid should not be uploaded in any other place except Cover No. 2 as mentioned above. If price is indicated in any other document/with any other document (Techno-Commercial Bid) then the offer shall be summarily rejected.

Please note that the quoted price inclusive all but excluding GST will be considered for the purpose of comparison / evaluation of final quotation. The bidders must quote premium for the insurance sought which is mandatory for valid offer. Incomplete and /or part offer, if any, will be liable to be rejected.

The Bidders Eligibility Criteria (Annexure-A) will be evaluated first, the Techno- Commercial Bids of the bidders (Annexure-B) who have satisfied Bidders eligibility Criteria (as per Annexure-A) will be evaluated thereafter and after satisfactory compliance of all the parameters of the Techno-Commercial Bid (Annexure-B), the Price Bid of the qualified bidder will be opened. The Bidders are also to submit and upload in the NIC Portal, Integrity Pact (Annexure - C) and also certificate of Non deviation & Undertaking from the authorized signatory of the bidder (Annexure-E). The bids (except price bid) will be opened at 2.15 PM on 24.10.2025.

20. Price Bid - (Annexure-D)

Price bids of only techno commercially cleared bidders will be opened subsequently with due intimation to the qualified bidders.

21. Bidders Criteria:-

INTEGRITY PACT

The Principal intends to award, under laid down organizational procedures, contract for purchase of Builders' Risk Policy w.e.f. November 2025. The Principal values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness /transparency in its relations with its Capital Bidder(s).

In order to achieve these goals, the Principal will appoint an Independent External Monitor (IEM), who will monitor the tender process and the execution of the contract for compliance with the principals mentioned above.

Section 1 - Commitments of the Principal

- [1] The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:-
- **a.** No employee of the Principal, personally or through family members, will in connection with the tender for , or the execution of a contract, demand, take a promise for or accept for self or third person, any material or immaterial benefit which the person is not legally entitled to.
- **b.** The Principal will, during the tender process treat all Bidder(s) with equity and reason.
- **c.** The Principal will in particular, before and during the tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the tender process or the contract execution.

Section 2 - Commitments of the Bidder(s)

- [1] The Bidder(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.
- **a.** The Bidder(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal's employees involved in the tender process or the execution of the contract or to

any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.

- **b.** The Bidder(s) will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- **c.** The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act; further the Bidder(s)/Contractor(s) will not use improperly, for purpose of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- **d.** The Bidder(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- [2] The Bidder(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.

Section 3 – Disqualification from tender process and exclusion from future contracts.

If the Bidder(s) before award *or* during execution has committed a transgression through a violation of Section 2, above or in any other form such as to put his reliability or credibility in question, the Principal is entitled to disqualify the Bidder(s) /Contractor(s) from the tender process or take action as per the extant procedure of the company.

Section 4 – Compensation for Damages.

If the *Principal* has disqualified the Bidder(s) from the tender process prior to the award according to section 3, the Principal is entitled to demand and recover the damages equivalent to earnest Money Deposit /Bid Security, if any.

Section 5 - Previous Transgression

- (1) The Bidder declares that no previous transgressions occurred in the last 3 years with any other company in any country conforming to the anti-corruption approach or with any other Public Sector Enterprise in India that could justify his exclusion from the tender process.
- (2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process or action can be taken as per the procedure mentioned in "Guidelines on Banning of business dealing".

Section 6 - Equal treatment of all Bidders

(1) The Bidder(s) undertake(s) to demand from all sub-contractors a commitment in conformity with this Integrity Pact, and to submit it to the Principal before contract signing.

- (2) The Principal will enter into agreements with identical conditions as this one with all Bidders, Contractors and Sub-contractors.
- (3) The Principal will disqualify from the tender process all bidders who do not sign this Pact or violate its provisions.

Section 7 – Criminal charges against violating Bidder(s) Contractor(s) / Subcontractor(s)

If the Principal obtains knowledge of conduct of a Bidder, Contractor or Subcontractor, or of an employee or a representative or an associate of a Bidder, Contractor or Subcontractor which constitutes corruption, or if the principal has substantive suspicion in this regard, the Principal will inform the same to the Chief Vigilance Officer.

Section 8 – Independent External Monitor / Monitors

- (I) The Principal appoints competent and credible Independent External Monitor for this Pact. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.
- (2) The Monitor is not subject to instructions by the representative of the parties and perform his functions neutrally and independently. He reports to the Chairman GRSE
- (3) The Bidder(s) accepts that the Monitor has the right to access without restriction to All Project documentation of the Principal including that provided by the Bidder(s). The Bidder(s) will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The monitor is under contractual obligation to treat the information and documents of the Bidder(s) with confidentiality.
- (4) The Principal will *provide* to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Bidder(s), The parties offer to the Monitor the option to participate in such meetings.
- (5) As soon as the Monitor notices, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or take corrective action, or to take other relevant action. The monitor can in this regard submit non-binding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.
- **(6)** The Monitor will submit a written report to the Chairman, GRSE within 8 to 10 weeks from the date of reference or intimation to him by the Principal and, should the occasion arise, submit proposals for correcting problematic situations.
- (7) Monitor shall be entitled to compensation on the same terms as being extended to /

provided to Independent Directors on the GRSE Board.

- (8) If the Monitor has reported to the Chairman GRSE a substantiated suspicion of an offence under relevant IPC/PC Act, and the Chairman GRSE has not, within the reasonable time taken visible action to proceed against such offence or reported it to the Chief Vigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioner.
- **(9)** The word 'Monitor' would include both singular and plural.

Section 9 – Pact Duration:

This pact begins when both parties have legally signed it. It expires for the Contractor 18 months after the last payment under the contract, and for all other Bidders 6 months after the contract has been awarded.

If any claim is made / lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged / determined by Chairman of GRSE.

Section 10 – Other provisions:

- 1) This agreement is subject to Indian Law. Place of performance and jurisdiction is the Registered Office of the Principal i.e. Kolkata.
- 2) Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.
- 3) If the Contractor is a partnership or a consortium, this agreement must be signed by all partners or consortium members.
- 4) Should one or several provisions of this agreement turn out to be invalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
