Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 20. RISK PURCHASE:

If successful tenderer fails to supply material within the stipulated delivery date, GRSE reserves th e right to procure same or equivalent material from alternative sources at the vendor's risk, respon sibility and cost.

21. ORDER COMPLETION:

Order once placed must be completed in full within the stipulated delivery period, unless otherwise specially agreed by the buyer in writing.

22. INDIVIDUALITY OF CONTRACT: -

This order shall be treated as an individual contract, shall not allow any general lien to the portions and shall not get any prejudice in execution due to situation arising out of some other contract that you may have with GRSE.

23. **PAYMENT TERMS:**

100% payment through ECS / NEFT mode within 30 days on submission of clear bill along with Gate Stamp ed Receipted Challan, GRN, clear acceptance certificate/work done certificate of user dept. (Main Unit), an d upon submission of 5% PBG document valid for 90 days post completion of mutually agreed guaranteed period through OBPS portal. In absence of PBG, 90% payment can be made and 10% will be retained till guarantee period.

24. **PERFORMANCE BANK GUARANTEE (PBG):**

Materials / Equipment to be supplied are guaranteed for free replacement / repairs, against defecti ve design, material, workmanship for a period of 36 months from the date of receipt of material at GRSE. During the guarantee period the vendor should attend to any defect within 48 hours of reporting and should replace the defective part, free of cost, to make the equipment functional or the whole equipment is to be replaced free of cost, if required, within 07 days of reporting.

A Bank Guarantee covering 05% value of the contract is to be furnished before claim of payment, keeping the same valid for the three months beyond agreed guarantee perio d from the date of despatch / supply of last consignment. 28. **FALL CLAUSE:**

B3. **PATENT RIGHT:**

34. **CANCELLATION OF ORDER:**

GRSE reserves the right to cancel the tender / **order** in part / full at any point of time without assig ning any reason thereof and with no financial implication.

B5. **FORCE MAJEURE CLAUSE:**

Standard Force Majeure Condition at the supplier's own works / establishment shall only be accept ed. The failure of the sub-contractors of the suppliers shall not be accepted as a Force Majeure Condition. Vendor is to submit relevant proof / document well in time to buyer to inform F.M. condition

B6. **ARBITRATION:**

- iv) The Award of the Sole Arbitrator shall be final, conclusive and binding upon the parties.
- v) In the event of the death or resignation or incapacity or whatsoever of the said Sole Arbitrator if appointed by the parties mutually the said parties may again appoint a suitable Substitute Arbitrat or in place of the erstwhile Sole Arbitrator to continue with the proceedings. - vii) The cost of the arbitration, fees of the arbitrator, remuneration of the stenographer and clerk, s tamp paper etc. shall be shared equally by the parties, unless otherwise directed by the Sole Arbitr ator. The venue of arbitration shall be at Kolkata and unless otherwise decided by the parties or by the Sole Arbitrator himself, the venue shall be the premises of Garden Reach Shipbuilders & Engin eers Ltd. located at 43/46, Garden Reach Road, Kolkata 700 024.
- viii) The language of the proceeding shall be in English.

B7. **JURISDICTION:**
