

NOTICE FOR IMPLEMENTATION OF POLICIES FOR MICRO & SMALL ENTERPRISES, 2012 REGARDING BENEFITS BEING ACCORDED TO THE MICRO & SMALL ENTERPRISE VENDORS

GRSE is implementing the Public Procurement Policy for Micro & Small Enterprises (MSEs) Order 2012 and subsequent amendments to encourage participation of MSEs in GRSE's shipbuilding and manufacturing of various engineering items efforts, details of which are as under :-

1. This policy for MSEs shall apply to all the MSEs registered with District Industries Centre or Khadi & Village Industries Commission or Khadi & Village Industries Board or Coir Board or National Small Industries Corporation or Dte. of Handicraft & Handloom or any other bodies specified by Ministry of Micro, Small & Medium Enterprises.

Relevant document, Udyam Registration Certificate and/or as specified by the Ministry of MSME, for manufacture/supply of concerned equipment/goods/services, must be submitted along with the offer for such purpose to claim the benefit.

2. The 'Public Procurement Policy for Micro & Small Enterprises (MSEs) Order, 2012' and subsequent amendments / guidelines / press publications / circulars to the Order, as issued by the Ministry of MSME, shall be applicable as on the date of opening of the price bids.

3. The bidders are advised to check the website of the Ministry of MSME for details of the amendments / circulars issued by the Ministry of MSME.

4. The plan of procurement by GRSE from MSEs in the financial year 2024-25 is ₹ 400 crore approximately.

11. All Micro & Small Enterprises are required to declare their Udyam Registration Certificate number on the Central Public Procurement Portal (CPPP). Documentary evidence of the said declaration is to be submitted along with the techno-commercial bid failing which benefits being accorded to Micro & Small Enterprises will not be extended.

12. GRSE, being a public sector enterprise, endeavours to support the Micro and Small Enterprises for facilitating their promotion and development and enhancing their competitiveness.

Bidders may therefore procure all such parts / components, as contained in the list available on GRSE website, required in manufacturing of the ordered equipment / products, from MSEs and a certificate to that effect (with details of the vendors, value of procurement and quantity) may be furnished with the bills.
