1. The submission of the Life certificate for Post-Retirement Medical Insurance Scheme for FY 2026-27 (**both PRE – 2007 & POST – 2007**) is ongoing at present. In accordance with the Administrative Order, a self-declaration has to be submitted through on-line process only.
2. This is being intimated to all ex-employees that the date of submission of Life Certificate for Group Medical Insurance Policies has been extended up to **30<sup>th</sup> June 2026**.
3. **Further, this is to inform that on-line submission of Life Certificate through the retirement section of GRSE website is mandatory from this year onward. No hard copy of Life Certificate will be forwarded to you and neither it will be accepted by Medical Cell through mail or hard copy. Only On-line submitted Life Certificate will be accepted.** This has already been informed in the last year.
4. **For on-line submission of Life Certificate, follow the steps: -**  
**Open Google Chrome → type “ <https://grse.in>” → Click on “Retirement” section → click the link(Online Submission of Medical Life Certificate) → select PRE-2007 / POST-2007→ select “Confirm & Proceed” → enter Ex-MA No and Date of Birth (in the format DD – MM – YYYY) → click “Save and Process → select option “ Both Employee and spouse / Only employee / only spouse” as the case may be→ a page will open ( check all details) → fill the blank columns and click “Confirm and Proceed” → upload photo and click “Save and Proceed” → another page will open. Check all details(draft) and click “Confirm & Submit”.**
5. **Those who are willing to opt Top Up Scheme, are requested to deposit requisite amount and send the filled-up form at [psmbs@grse.co.in](mailto:psmbs@grse.co.in). **Last date of submission of Top Up Premium: 23.05.2026****
6. List of Life Certificate & Top Up will be uploaded in the GRSE Post Retirement Section in the GRSE website. ***Kindly Check your name.*** As per the extant policy, if Life Certificate is not submitted, your Post-Retirement Medical facility will be withdrawn.
