The company came into being in 1884 as a small factory on the Eastern Bank of the river Hooghly. In 1926, the amalgamation of workshopsof River Steam Navigation Company (RSNC) and British India Steam Navigation Company (BISN) was finally effected and managed as a partnership concern. Garden Reach Workshop was incorporated as a Company under the Indian Companies Act of 1913 with effect from 26 February 1934. The company was taken over by the Government of India on 01 April 1960.
