#### **ARTICLE 5: PLACE OF WORK & FACILITIES:**

The work is to be carried out by the contractor at their own premises utilizing their own resources and facilities including all consumables and labour at no extra cost.

#### **ARTICLE 6: JOB EXECUTION & DELIVERY CLAUSE**

Manufacturing and Supply is to be carried out strictly as per SOTR, Drawings of each Bridge Components. Each Bridge Component must be completed as per delivery schedule from the date of issue of complete quantity of GRSE "Free issue Material".

#### **ARTICLE 7: WARRANTEE CLAUSE**

Warranty of the job: Applicable

Period of warranty: 24 months from issue of ICGRN.

#### **ARTICLE 8: PRICE**

Price quoted will be firm and fixed for the entire contract period till completion of supply of materials and for the period of one year from purchase order date. **Price is to be quoted as per details of taxes & duties in NIC.IN Portal.** No escalation whatsoever will be considered under any circumstances within the stipulated period of contract.

#### **ARTICLE 9: ESCALATION**

No Escalation will be applicable.

#### **ARTICLE 10: UNREASONABLE QUOTES**

In case the price of L-1 Bidder found to be unreasonable low and/or express desires to withdraw from the tender then such bid will be cancelled and EMD will be forfeited and may be evaluated for tender holiday by the Company.



However in case the L1 Bidder agrees to take-up the job with such unreasonable low quote, say lower by 30% of estimate and also if the difference in price between L1 & L2 is 30% or more then Company may consider such request of the Bidder as a special case subject to the Bidder agreeing to give Security Deposit of 20% of the PO value.

#### **ARTICLE 11: OFFER VALIDITY**

Offer is to be valid for 120 days from the date of opening of Part-I bid i.e. Techno-commercial bid. Under exceptional circumstances GRSE may request for extension of price validity, beyond 120 days against valid reason.

#### **ARTICLE 12: CONDITIONAL OFFER**

Conditional offers w.r.t. SOTR will not be accepted. However in case of bidder wish to deviate on any/ same commercial Terms & conditions, then separate deviation statement has to be uploaded along with Part-I bid. However GRSE reserves the right to accept / reject the deviations / bid with deviations after giving reasonable opportunity to the Bidder. If the deviation is acceptable to GRSE then suitable loading for such deviation on the price quoted by the bidder will be considered prior to determine the L1 price.

#### **ARTICLE 13: DETERMINATION OF L1**

L1 will be decided line item wise.

#### **ARTICLE 14: OPENING OF BIDS**

Part I techno-commercial bid will be opened on the date declared in NIT. Part II bid will be opened post techno-commercial evaluation by GRSE. Price bid of only those who qualifies techno-commercially will be opened. Opening date of Price Bid will be intimated accordingly to all qualified bidders. Disqualified bidders, either during technical assessment or commercial discussion will also be intimated about their non-consideration for farther processing. If any bidder qualifies for trial order, price bid of the bidder shall not be opened prior to successful completion of trial.

#### **ARTICLE 15: MICRO & SMALL ENTERPRISES**

Purchase preference may be given to eligible Micro and Small Enterprise Firms as per MSME Act provided, the tendered job is listed in their MSE document. (Detail at Clause 1 of STAC)

#### ARTICLE 16: AWARDING JOBS TO MULTIPLE BIDDER

GRSE at its discretion may engage multiple Suppliers/sub-contractors to maintain & in the interest of the delivery/construction schedule. (Detail at Clause 2 of STAC)

ARTICLE 17: AADITIONAL ARC ORDER CLAUSE: GRSE BB will enter into Annual Rate Contract with L1 Bidder against each line item for the period of one year. If L2, L3 & L4 Bidders agrees to supply the tendered items at L1 rates, GRSE BB will enter into Annual Rate Contract with L2, L3, and L4 Bidders with same terms and condition as par with L1 Bidder. GRSE may order Additional requirement Quantity up to 300% of each line items based on the "Performance" of the established ARC Vendors within the validity period of Rate Contract.

#### **ARTICLE 18: INSTRUCTION TO THE BIDDERS**

a. Before submitting a bid, bidders are expected to examine the Bid Documents carefully, if they



- desire, may visit the work front, fully inform themselves of existing conditions and limitations including all items described in the Bid Documents. NO consideration will be granted for any alleged misunderstanding or the materials to be furnished, work to be performed or actual considerations to complete all work and comply with conditions specified in the Bid Document.
- b. Any qualified deficiency, errors, discrepancies, omissions, ambiguities or conflicts in the Bid Documents, or there be any doubts as to the meaning of a provision or requirement shall immediately brought to notice of GRSE Tendering Dept. in writing not less than 07 days prior to bid closing date.
- c. It is understood that in receiving this bid, GRSE assumes no obligation to enter into a contract for the WORK covered by this bid request. GRSE reserves the right to reject any and all unqualified proposals or waive irregularities therein. GRSE reserves the right to evaluate each and every proposal and accept the whole or any part of the tender and the Tenderer shall be bound to perform the same at the rates quoted.
- d. GRSE also reserves the right to reject any and all bids and accept the bid, which in its opinion, appears to be most advantageous to GRSE. Receipt and review of this Bid Request constitutes an agreement of confidentiality between GRSE and each of the contracting Firms preparing its Bid. GRSE reserves the right to change the form of this request to Bids, or make clarifications thereto, within a reasonable time before date of submission of Bids.
- e. Bidders objecting on any grounds to any bid specification or legal requirements imposed by these bidding documents shall provide written notice to GRSE within 10 calendar day from the day bid document was made available to public. - g. Post submission of Tender, such drawings and technical information are to be physically returned. Also all soft copies are to be destroyed and a self-certification to be submitted during CNC. Failing which the processing of bid will not be continued.
- h. Bidder is allowed to submit only one Bid under any capacity / status.

#### **ARTICLE 19: BID REJECTION CRITERIA**

Following bid rejection criteria may render the bids liable for rejection:

- (a) Bidder's failure to furnish sufficient or complete details for evaluation of the bids within the given period which may range in between two to three weeks depending on the deficiencies noticed in the drawings / technical data which shall not however conflict with validity period.
- (b) Incomplete / misleading / ambiguous bid in the considered opinion of the Technical Negotiation Committee (TNC) of GRSE.
- (c) Bid with technical requirements and/or terms not acceptable to GRSE / Customers / External agency nominated, as applicable.
- (d) Bid received without qualification documents, where required as per the tender.
- (e) Bid not meeting the pre-qualification parameters / criteria stipulated in the Tender Enquiry.
- (f) Bid with validity expiry date shorter than that specified in the Tender Enquiry.
- (g) Bidders who have not agreed for the fixed price till the validity of the tender or have quoted the variable price.

#### **ARTICLE 20: SUBMISSION OF BID**

- (c) GRSE reserves the right to accept / reject any Tender in full or in part without assigning any reason.

#### 2. GRSE Scope of Supply to Vendors:

A. GRSE BB will Supply the following steel raw material as "Free Issue Materials" to Vendors <u>as applicable</u> against each Bridge Component.

a. Joist/Beam 250 x125 IS: 2062 Grade E410

b. ISMC 75x40 IS: 2062 Grade E410

B. This is Non-disclosure agreement type Tender and Drawing will only be discussed during Pre-Bid meeting. Please note that all the drawing are confidential in nature, Vendor Should not copy any part of Drawing and not to be used for any other purpose. **Drawing will only be issued after placement of PO and submitting the Bond of Undertaking and Non-Disclosure Bond**. C. GRSE BB will supply Forklifts, Cranes etc. as applicable for Loading of Raw Materials at SSY-TU/RBD/Main/ 61Park and Unloading of Finished products at Stores 61 Park Unit.

### 3. Important Terms and conditions for Sub-Contract vendors:

- a. Indemnity Bond, Non-Disclosure Bond, Bond of Undertaking, Non-Competitive bond, Integrity Pact (if applicable) and insurance must be submitted within 07 working days from the Date of Issue/received of PO by the vendor.
- b. When Raw Material is available and GRSE BB had given written permission to collect the Material along with PO. Free Issue Material must be collected within 12 working days from the Date of Issue/received of PO by the vendor from GRSE BB Stores after submission of Bonds. However, on written intimation by GRSE BB and in case of urgent requirements, Free Issue Material must be collected within 05 working Days from date of intimation after submission of bonds from GRSE BB Stores.
- c. When Raw Material is NOT available. GRSE BB will send written intimation for availability of Raw material and Free Issue Material must be collected within 03 working Days from date of intimation after submission of bonds from GRSE BB Stores.
- d. All sub-contract vendors must report before 10.00AM on working days for collection of Free Issue Material with all relevant documents and information.
- e. BB Components Drawing must be issued from the GRSE BB office within 04 Working days from the date of submission of bonds.
- f. All Quality inspection calls must be given at least 03 day advance.
- g. After completion of final inspection the finished material must be dispatched within 02 working days.
- h. MRS Files must be submitted to GRSE BB for further audit by GRSE Audit Deptt within 15 days from the date of ICGRN.
- i. All above points must be strictly compliance otherwise, GRSE May take suitable actions as per STACs

#### 4. Vendors Scope of Manufacturing and Supply:

- i. All Balance Material as per BOM, Drawing which are not supplied by GRSE BB. Such as Stiffener, plates, bracket etc.
- ii. Joist/Beam OR Channels will be issued only in "Cut to Size" basis as per drawing to the vendors. Vendors will arrange gas cutting at GRSE Stores for "Cut to Size" as per Drawing at their own cost.
- iii. During Inspection, vendor has to provide the all working gauges required to measure critical dimensions/positions.
- iv. All Gauges for inspection purpose. At initial stage working gauge to be manufactured by Vendor and to be approved by GRSE BB Deptt.
- **v.** Gauges in case of any exigency, if supplied by GRSE then equivalent rental charges on per day basis will be imposed and equivalent amount will be deducted from the Vendor's Bills.
- vi. All Consumables, tools, tackles etc.
- vii. Cutting of Raw Materials in "Cut to Size" as per Drawing so that minimum scrap will generate.
- viii. Transportation of raw materials to vendor's premises and delivery of Finished Components and return of scrap/excess material to GRSE Stores will have to be arranged by the vendor at their cost.
- ix. Materials supplied by GRSE shall be stored with proper care and processed in vendor's own factory premises and shall not be taken out/subcontracted to other parties without taking consent from GRSE. GRSE representatives may inspect the stock time to time.
- x. Manufacturing of Components as per Drawing, quality work must be done.
- xi. Off-cuts or scraps generated from Joist/Beam/Channels during manufacturing process shall have to be returned to GRSE without fail.
- xii. Necessary Insurance to cover risk in transportation of raw material and other sub-parts to vendor's premises and delivering the finished product & returning scrap/excess material, if



any, from vendor's premises to GRSE stores will be done by vendor at vendor's cost keeping GRSE as beneficiary.

#### 5. Vendors Scope of Olive Green Painting:

- i. OG Painting of Tendered components has to be done all over by Red Oxide Zinc Chrome primer conforming to IS:2074 followed by two coats of Paint Olive Green.(Shade No 294) conforming to IS:13607 after thorough cleaning as per clause 6.2 of IS:1477(Part II).
- ii. Paint material (Olive Green IS-8982 & Red-Oxide IS-2074) & Grit required for blasting and painting will be under vendor's scope completely, vendor to submit related purchase documents of paint materials duly endorsed and submit to GRSE on behalf of painting party/agency during delivery of finished components.
- iii. Vendor will also arrange Air Compressor (Electric Driven type), hose, nozzle and other necessary fittings and grit at their cost.
- iv. Contractor should have the necessary painting gears/accessories like different brushes, spray gun for Airless spray painting, various stencils, Aluminum Paint, stirrers, wire brush, emery cloth etc. at their premises and same provide to the painter.
- v. Party to arrange sufficient manpower & any other materials required to carry out the work within this contract.CI Grits, Grade G70 to BS, EN, ISO11124, PT.2, are to be used. The contractor must furnish manufacturer's certificate confirming that the CI Grits procured are of required grade which will be audited by GRSE BBQA from time to time.
- vi. Surface preparation by shot Blasting followed by applying of two coats Red Oxide paint on Component. The Components are to be finish painted by applying two coats of Synthetic Enamel paint viz, (Olive Green color) and stenciling to be done at vendor premises. Application of primer is to be done by Brush only
- vii. After finish painting and before handing over finish material to GRSE, Greasing on the holes and stenciling of Part No., Name, month of application and vendor ID are to be done.
- viii. Painting will have to be done by Brush or Airless spray painting method at the discretion of GRSE. Vendor should carefully avoid intrusion of paints within the holes of items subject to gauging.
- ix. Inspection will be carried out at every stage of operation by GRSE. Component are to be thoroughly cleaned by emery cloth/wire brush at each stage of painting duly certified by inspector. Paint Material is to be inspected and approved by GRSE (BB-QA) and inspection shall be done by GRSE (BB-QA) on the basis of acceptance Test Report of Paint from NTH/NABL accredited lab & firm's material Test & Guarantee Certificate. GRSE reserve right to cross check the quality of paint material and all costs are to be borne by the vendor. Vendor has to furnish warranty for life of the coating for a period of 24 months from the date of supply against each lot. Vendor to apply grease within all holes of items after completion of complete shot blasting and painting process.
- x. FINAL GAUGING: Painted material will undergo final gauging/checking after the completion of all fabrication and painting process and checking of same. Dimensional clearance would be given on affirmative witness with all relevant gauges on the painted Components. Adequate greasing shall be ensured on the holes on completion of fabrication & final clearance.

#### 6. QUALITY SCOPE OF INSPECTION:

- i. During Inspection vendor has to provide the all working gauges required to measure critical dimensions.
- ii. Visual (w.r.t 'Aesthetic look' of the job toward the acceptable standard)
- iii. Dimensional, through valid calibrated instruments/ gauges.
- iv. Scrutiny of Test certificates (as applicable).
- v. Welding types (i.e. fillets etc., as shown in the drawings), by proper gauging method wherever applicable.
- vi. Relevant QA plan may be referred to during inspection.
- vii. Inspection of components shall be performed in stages. The vendors shall arrange for inspection accordingly.
- viii. Welding: Electrodes of ESAB/ Philips/Advani or any IRS/ MMD/ LLOYDS approved make only shall be used. Declaration to this effect has to be furnished by the vendor at the time of



inspection. GRSE(BBQA) or its authorized inspector(s) may at their discretion check/ verify the welding electrodes being used at any stage of manufacturing process at vendor's premises, if so required. In case of option for MIG welding, prior approval of make of MIG-wire should be obtained from GRSE. Welding work to be carried out by qualified welders, whose documents may be checked during inspection.

ix. Bolts & nuts: Gauging with `GO & NO-GO' calibrated thread Gauges for proper matching of threads between the `Bolts & Nuts' with interchangeability, to the extent of 100% or, as may be deemed fit by our inspector.

#### 7. Identification Markings on GRSE Bailey Bridge components & Stenciling Clause:

i. Finished component (excl. Fasteners) should be clearly have Name Plate / Embossed/

<u>Engraved/Steel punched</u> with proper Stenciling with the following Identification markings at proper location, as per the instruction of GRSE Bailey Bridge dept.

• Company Name : GRSE

Component NomenclaturePart no.:

• Month & Year of Manufacturing : MM/YY

• Serial No. : To be obtained from BBQA.

• Vendor ID\* (refer note below) : Last 04 digits of SAP Vendor Code.

#### Note:

\* For Panels, Chord Reinforcements, Decks & Transoms, Vendor ID shall be last 4 digits of Vendor code.

- ii. Serial Nos. for <u>Panels, Chord Reinforcements, Decks & Transoms shall be provided by GRSE BB-QA</u> against their respective Purchase Orders. Vendors are requested to approach GRSE BB-QA for the same.
- iii. Strict Compliance of the above points is mandatory.
- iv. The same shall be verified by GRSE Inspectors during inspection of the component.

#### 8. NORMS:

- i. If there is shortage of Oxygen for industrial propose than utilization of alternate technology like Plasma Cutting, Laser Cutting, etc. may be used for production.
- ii. Vendor is to offer material for inspection only, after full readiness/inspection by themselves.
- iii. All measuring instruments/gauges required for inspection shall be provided by vendor to the inspection authority.
- iv. Inspection Authority shall be GRSE (BBQA) or by other inspecting agency as decided by GRSE.
- v. Goods shall be initially inspected by GRSE (BBQA) at vendor's premises/works & finally at GRSE works/store on receipt.
- **9. TEST CERTIFICATE**: Correlated Material Test Certificates of the test pieces (raw material) stamped by GRSE (BBQA)/its authorized representative from NTH/NABL registered Laboratories only conforming to the following (as per drawing specification) must be furnished by the manufacturer at their own cost. The no. of test pieces shall be as per IS: 2062.
  - i. Chemical: C%, Mn%, S%, P%, Si%, CE etc (as applicable) as per IS: 2062.
  - ii. Physical: UTS, YS, % elongation etc (as applicable) as per IS: 2062.
  - iii. GRSE (BBQA) reserves the right for cross checking above.

All test certificates & shop test reports are to be produced by the vendor during inspection and to be submitted along with dispatched material.

10. SCRUTINY OF TEST CERTIFICATES & SHOP TEST REPORTS OF THE VENDOR.



- a) Counter checking, at the discretion of GRSE, of physical and chemical properties of vendor's material from any lot of supply, may be carried out by GRSE (BB/QA) on receipt of material at GRSE Stores.
- b) GRSE test results/observations will be final and binding upon the supplier/ vendor on the matter of final acceptance of the material of the related lot.
- c) Materials shall be inspected at vendor's works before dispatch. Prior inspection call letter to be sent to GRSE for this. Final ICGRN (Inspection Cum Goods Receipt Note) shall be issued on receipt and inspection (by GRSE QA) of material at GRSE, 61 Park stores.
- **11. WARRANTY**: All the manufactured components should be guaranteed for **24 months** from the date of ICGRN. In case of any defect, if detected/reported within the Guarantee Period, the same shall be rectified by the contractor free of cost at place where components are kept isolated or at site, due to defective workmanship with respect to its application.

- 1) That in consideration of raw materials as mentioned in the Contract, to be handed over to the Contractor in installments from time to time for the performance of the Contract, the Contractor hereby undertakes to indemnify and shall keep the Principal harmless and indemnified of, from and against any consequences, loss or damage caused to the Principal for the full value of materials. The Contractor agrees to acknowledge receipt of the initial installment of the raw materials after actual receipt as per details in the Schedule appended hereto. Further, the Contractor agrees to acknowledge actual receipt of subsequent installments of the raw materials as required from the Principal in the form of Schedules consecutively numbered which shall be attached to this Indemnity Bond so as to form an integral part of this Bond. The Contractor shall hold such raw materials etc. in trust as a "Trustee" for and on behalf of the Principal under their custody.
- 2) That the Contractor is obliged and shall remain absolutely responsible for the safe transit/protection and custody of the raw materials at their Premises ....., against all risks whatsoever till the raw materials are worked upon in accordance with the terms of the Contract and are returned and taken over by the Principal.
