# STANDARD TERMS AND CONDITIONS

- 1. <u>**TERMS OF PRICE:**</u> Please quote your Price (in INR) based on F.O.R. DEP Ranchi should be firm & fixed till execution of order in full.
- 2. Quantity indicated is the requirement of one year approx. Monthly requirement, as applicable will be informed to supplier from time to time by used Department which must be supplied within seven days or earlier.
- 3. Wherever brand name is indicated the rates are to be quoted for all brands separately. No other brand will be acceptable to us.
- 4. During the contract period (one year / if manufacturer provides any gift which was ordered on you) on purchase of their branded product which was ordered on you. GRSE / DEP reserves the right for making of bill only after deduction of cost of gift item from branded product ( main items ordered on you ) and will not insist for supply of gift item along with the main item ( branded item ) to DEP.
- 5. Rates are to be given for each item and shall remain firm and fixed for a period of (1) one year for supply from date of order.
- 6. The supply of provision shall be arranged at Diesel Engine Plant (DEP) site by their own transport and labour. No additional charges for transport and labour will be payable by DEP.
- 7. The quantities of supply indicated are approximate annual requirement. DEP reserves the rights to vary the quantity of required items by  $\pm$  20 %.

#### 8. Tender Fee :-

- (a) Parties downloading tender documents from website need to submit Demand Draft / Pay order of Rs. 500/- (Five hundred only) (Non Refundable) in favour of "Garden Reach Shipbuilders & Engineers Ltd.," payable at Ranchi from Nationalised / scheduled Banks towards cost of tender document.

## <u>ANNEXURE – B</u>

(iv) Unsuccessful bidder will be refunded for which the Tenderer shall make an application addressed to Manager (Safety / Canteen), DEP / GRSE Ltd. Ranchi.

- (v) EMD amount may be forfeited in case of :-
  - (a) The bidder withdraws the bid after opening / during the period of its validity.
  - (b) The Successful bidders fails within the specified time limit to :-
    - (i) Acknowledge the LOA / Order
    - (ii) Furnish the required security deposit
    - (iii) Nonperformance of the contract by the bidders.

#### 10. SECURITY DEPOSIT :-

Successful tenderer is required to deposit an amount of equivalent to 3% of the total contract value as security amount deposit (interest free). The security amount deposit will be retained by DEP as interest free deposit during the tenure of the contract. However, if desired by the party, the earnest money initially deposited with tender, shall be adjusted, provided, an application in writing is made and balance amount is paid along with the application.

- 11. Tender is subject to deposit of tender fee and Earnest Money in absence of which the offer will be rejected outright. Successful bidder(s) are to submit security deposit as per tender terms.
- 12. The contract shall remain valid for one year from the date of its commencement.
- 13. DEP reserve the right for extending the contract for a period of another three months on expiry of the one year contract, if necessary, in the same rate and terms and condition.

#### 14. INSPECTION:-

All goods supplied according to the purchase order shall be inspected, at DEP and acceptance of the goods shall always be subjected to such inspection. If the goods supplied are not as per order specification or otherwise not satisfactory for any reason of which the DEP will be sole judge, DEP shall be entitled to reject the supplies, cancel the purchase order, buy requirement from elsewhere and recover from SELLER the extra cost incurred for replacement.

#### 15. SUBMISSION OF BILL / INVOICES:

SELLER's bill for goods supplied by the SELLERS and accepted by DEP shall be supported by a copy of the order and PUCCA receipt for goods issued by the authorized stores officer of the DEP. For purposes of payment the date of actual submission of these documents will apply and not the date of supply of materials or the date of the bill raised prior to the receipt of 'PUCCA' receipt unless otherwise specially agreed to for special payment clause and incorporated in the order.

16. The supplies are to be made only between 10.00 AM 12.00 Noon and 2.30 PM to 04.00 PM. No supplies to be delivered other than time stipulated above.

### 17. RISK PURCHASE CLAUSE:-

If successful tender fails to supply material within the stipulated delivery date, GRSE reserves the right to procure same or equivalent materials from an alternative source at the vendors risk, responsibility and cost. Any extra cost incurred in the procurement of the material from alternative source will be recovered from the security deposit / Bank Guarantee and if the value of the material under risk purchase exceeds, the amount of security deposit and / or Bank Guarantee, the same may be recovered if necessary by due legal process.

18. In case of delay in delivery liquidated damages @ ½ % per week or part thereof up to a maximum of 5 % of the order value will be deducted from the bill against the supply.

#### 19. ARBITRATION:-

In case of dispute, if any, between GRSE and the contractor, the matter shall be referred to the sole discretion / arbitration of CMD of GRSE or his nominated representative and his decision will be final and binding.
