- 2. PRE-QUALIFICATION CRITERIA
- a. Technical Criteria -

- a) Bidder shall have experience of successful execution of Similar Nature/Ty pe of Job i.e. Supply / Supply & Installation of Fenders (excluding irrelevant j obs other than supply and installation of Fenders. If other irrelevant items ar e included in the above-mentioned PO, the value of these items will be excluded from total value of the executed PO and Resultant value after deduction will be considered for evaluation) during last Seven (07) years ending 31st D ecember'2023. Supporting documents meeting Technical Eligibility Criteria to be submitted along with the bid. Also, full contact details like name, address, telephone numbers of the person under whose direct jurisdiction the work was executed etc. to prove that they had carried out such works successfully in any PSU / Corporate house / Industry.
- b) Bidder has to full fill experience in successful completion of afore said similar jobs of value (including GST) not less than Rs. 155 lak hs for one job OR not less than Rs. 78 lakhs each for two jobs OR n ot less than Rs. 31 lakhs each for three jobs in last Seven (07) year s ending 31st December'2023.
- b. The bidder should give self-certification (as per Annexure-2C) that they have neither been Blackliste d nor have received any tender holiday from any PSUs/Central & State Govt. Organizations or any oth er Government / Quasi Government Organizations during last 03 (three) years ending on 31.12.2023. The bidder has to submit self-certification for the same along with the techno-commercial offer. GRS E reserves the right to independently verify the same. In case violation of declaration is detected at an y stage of tender process and during currency of contract, the order will be terminated.

Note:

- a) If any bidder has been black listed by any PSUs/Central & State Govt. Organiz ations or any other Government / Quasi Government Organizations, then the bid der is not eligible to participate in this tender. If any discrepancy is detected at any stage of the tender, then the offer submitted by the bidder / contract awarded to the bidder will be cancelled and EMD/SD shall be forfeited and appropriate action will be taken in accordance with the vendor policy of GRSE.
