CHARGES FOR ELECTRICITY & OTHER SERVICES

1. Vessel shall pay for the electricity supplied to it by GRSE at actual.
2. The remaining services such as mandatory yard services, Dock Block Preparation, Tugs & Pilotage, Office, Toilet etc. and any other requirements if any, are chargeable at extra cost based on consumption and requirement basis.

TERMS & CONDITIONS FOR HIRING OF DRY DOCKS

1. Hiring of Dry Docks:
- Day 1 to day 10 of dry dock occupation: Per day rate.
 - From 11th to 30th day of dry dock occupation: 200% of the per day rates.
 - Beyond 30th day of dry dock occupation: 300% of the per day rates.
 - Calculations of No. of days starts from the day of allotment of dock for Dock Block preparation.
 - In case the vessel occupies the dry dock beyond the period for which the dry dock has been initially allotted, the hire charges shall be levied at 1.5 times the 'per day rates' prevailing at the end of initial contract period.
 - If the undocking on the day as per the undocking list is deferred on account of GRSE, the corresponding dry dock hire charges for the days of delay will not be charged. This shall, however, be not applicable for Saturdays/ Sundays / Holidays.

- (g) In case the vessel occupies the dry dock beyond the period for which the dry dock has been initially allotted due to reasons attributable to the GRSE, the dry dock hire charge for the period of such extension will not be chargeable. This shall, however, not be applicable for Saturdays / Sundays /Holidays.
- (h) If the vessel has requisitioned for a dry dock but it is not ready to dock at the time specified according to the docking programme, no charges shall be leviable provided an intimation of cancellation/ postponement of dry docking is given (excluding the day of docking) 2 days in advance of the specified time of docking. In such cases, a cancellation fee of Rs. 2323.00 will be recovered. However, if no such intimation is given 5% additional charge shall be recovered calculated on the rates applicable during the first 10 days of occupation for the period the vessel did not actually occupy the dry dock.
- (i) In case of vessel requiring laying of Special Keel Block due to their configuration, extra rental charges at the rates prescribed for Dry Dock Hire Charges above will be recovered for the period required for laying and removal of such special keel blocks. The rental charges for occupation of dry docks as above will be recoverable as per the period groups applicable.
- (j) Charges for each operation of re-docking or part of such activity are to be paid as per Docking - Undocking rates prescribed above.
- (k) The period of vessel's occupation of a dry dock counts from the time she enters into dry dock, upto the time she vacates the dry dock.
- (l) When more than one vessel are using the same dry dock as a common operation facility a rebate of 25% of the rate specified dry dock charges above shall be allowed for each vessel. This rebate shall also be applicable when a dry dock is shared with a GRSE vessel.
- (m) Crane facility is strictly as per availability and shall have no bearing on dry dock occupancy or hire charges.
2. Hiring of Berth:
- (a) Berths will be allotted purely based on the availability.
- (b) If any vessel does not work against its booking for work on Holiday due to reasons not attributable to GRSE, the Berth Hire for the shifts in which it does not work against such booking shall be levied at twice the rates specified at Beth Charges above.
- (c) In case a vessel idles due to non-availability or breakdown of the GRSE equipment or power failure at GRSE or any other reasons attributable to the GRSE, rebate equivalent to berth hire charges accrued during the period of idling of vessel shall be allowed.

3. Hiring of Cranes:

 - (a) Minimum 06 Hours hiring charge will be paid against each booking. Additional hourly charges beyond 06 hrs. will be paid on pro-rata basis.
