Dear Sir / Madam,

1. This has reference to our letter No. SECY/GRSE/BD-69/CA/3/2021-22 dated 17 May 2021 on the subject matter of 'Disclosure of Temporary suspension of Operation due to COVID19 Pandemic Situation under Regulation 30 of SEBI (LODR), 2015', from 16 May 2021 to 30 May 2021 due to Government of West Bengal Order No. 647-ISS/2M-22/2020 dated 15th May, 2021 declaring lockdown in West Bengal.

2. Further, due to the prevailing COVID19 Pandemic situation, the Government of West Bengal vide Order No. 707-ISS/2M-22/2020 dated 29 May 2021 extend the suspension of operation till 15 Jun 2021. Accordingly, we are informing pursuant to Regulation 30 of the SEBI (LODR), 2015, that the operations of the Company will remain temporarily suspended in all the West Bengal based Units, except for the personnel manning essential services with upto 15 Jun 2021. The employees are adhering 'Work From Home', wherever possible.

3. The overall impact on the operations of the Company are not immediately assessable. The Company is closely monitoring the situation and take appropriate action as per regulatory directives/ order/ guidelines as may be issued. The Management of the Company shall review
